#### **PROVISION OF MANAGEMENT SERVICES FOR LILONGWE CITY COUNCIL RESTHOUSE AND DESIGN OF A COMMERCIAL CENTRE**

**Procurement Ref No: LCC/IPDC/120/03/25/ REST HOUSE**

#### **Background**

The Lilongwe City Council (LCC) is a statutory body established under the Local Government Act (1998). LCC has land along Malangalanga Road opposite the Kachere Juvenile Rehabilitation Centre where it constructed a Rest House.

Meanwhile, LCC would like to redevelop the area into a Commercial Centre to cater for the growing needs of business people in the Central Business District (CBD). These needs are not only restricted to accommodation but also shops, banking halls, apartments and store rooms.

It is against this background that LCC wishes to engage a reputable firm in hospitality, business development, property management, estate development and architecture to help provide solutions to its defunct rest house and business prospects.

#### **Objective of the Assignment**

The main objective of the assignment is to rehabilitate and manage the resthouse. In addition, to design the whole plot into a Commercial Centre. The specific objectives of the assignment are as follows:

##### **LOT 1**

- 1) Rehabilitate the existing wings of the resthouse
- 2) Upgrade the existing wings to hotel standard
- 3) Manage the facilities
- 4)

##### **LOT 2**

- 1) Design high rise buildings with shops on ground and first floors plus apartments on the subsequent floors. These buildings to be built on either side of the access road – They must be 4 storey's
- 2) Design an access on land between the two lodging structures which will connect with the road that passes along Centenary Bank via the road that passes close to the prison entrance and connects with Malangalanga road.
- 3) Design at least two banking halls on either side of the access road
- 4) Design a food court and a garden
- 5) Design shops facing the road that passes along Centenary Bank, behind the lodging structures at the Rest House.

## **Expected Deliverables**

### **LOT1**

- 1) An upgraded rest house to hotel standard

### **LOT 2**

- 1) Technical Designs as per outlined objectives

## **Qualification and Experience**

The Interested Bidders should have a minimum of Master's Degree in Hospitality, Business Administration, Engineering and any relevant equivalent qualification. Demonstrated 5 years' experience in hospitality, business development, property management and estate development will be an added advantage. Must have a demonstrated financial capacity to carry out the assignment.
