The Malawi Electoral Commission (MEC) is a Constitutional Body created to supervise and direct the conduct of all statutory elections and determination of constituency and ward boundaries on behalf of the Malawi Government. MEC intends to use part of its budgeted funds in the 2025/2026 financial year to Procure **Election Management System (EMS) Spare parts**.

Late bid will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 5(b) at **10:00 Hours Local Time on 9th March ,2026**.
