A complete set of Bidding Documents in English may be purchased by interested bidders or their representatives at **MEC Cash Office, 2nd Floor, Room No. 316, Development House, City Centre** upon payment of a non-refundable fee of **MK10,000.00 (Ten Thousand Malawi Kwacha)** per tender, payable in **cash**. Bidders should then collect their set of bidding documents from the office of the Procurement Manager at the address given below at 7(a) during working days from **8.00am to 12.00pm** and from **1.00pm to 4.00pm**.
