- 1 The Nkhotakota District Council is implementing the Nkhotakota Basic Services Programme (KKBSP) from 2023 to 2027 with support from the Embassy of Iceland in Lilongwe. The development goal is improved livelihoods and resilience in rural communities by enhanced provision and use of inclusive and sustainable basic social services in Nkhotakota district. Most of the efforts are focused around building new and renovating public structures and institutions in the area of education, health and water services with emphasis on quality and climate resilient infrastructure. The support to the education and Gender sector of the Nkhotakota District Council is part of this programme.

All bids must be accompanied by a **Bid Securing Declaration Form**.
