To effectively administer and manage the grants, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grants.
- 2. The Chairperson of the Internal Procurement and Disposal of Assets Committee now invites sealed bids from eligible firms in Malawi.
- 3. Bidding will be conducted in accordance with the **National Competitive Bidding (NCB) procedures** specified in the Public Procurement and Disposal of Assets (PPDA) Act of 2025 and its Public Procurement Regulations 2020 of the Republic of Malawi.
