- 1. Bidding will be conducted in accordance with the **open National Competitive Bidding** (**NCB**) procedures contained in the Government of Malawi's Public Procurement Legal Framework and is open to all bidders.

- 3. A complete set of Bidding Documents in English may be purchased by interested bidders or their representatives at MEC Cash Office, 2nd Floor, Room No. 316, Chisankho House, City Centre upon payment of a non-refundable fee of MK10,000.00 (Ten Thousand Malawi Kwacha) per tender, payable by depositing to MEC bank account. Bidders should

then collect their bidding documents from the office of the **Procurement Manager** at the address given below at 6(a) during working days from **8.00am to 12.00pm** and from **1.00pm to 4.00pm.** Payment should be made through an **FDH Bank Account**: Malawi Electoral Commission, Account: 1040000098847, Blantyre Branch.

Bids clearly marked on the outer envelope with *tender name and reference number* must be delivered to the address at 6 (b) below and deposited in the tender box located at the Reception of MEC Head Offices in Lilongwe in Procurement Department at or before **14:00hours local time** on **8**th **August 2024.** Electronic bidding **will not** be permitted, and late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address shown at **6** (c) below at **14:00hours local time** on **8**th **August 2024.**
