Section I. Instructions to Bidders

General

Scope of Bid

- 1.1 The Procuring Entity indicated in the Bid Data Sheet (BDS), invites bids by the issue of this Disposal Document for the sale of unserviceable vehicle, tyres, furniture, mining laboratory equipment and ICT equipment as specified in Section 5, Details of Disposal list. These Instructions to Bidders shall be read in conjunction with the BDS. The subject of disposal, the disposal reference number, and number of lots of this Disposal Document are provided in the BDS.
- 1.2 The Disposal Document is issued under the disposal method indicated in the BDS.

2. Eligible Bidders

- 2.1 A Bidder may be a natural person or private entity.
- 2.2 A Bidder shall not have a conflict of interest.

Contents of Bidding Document

3. Sections of Disposal Document

3.1 The Disposal Document consists of Parts 1, 2, and 3, which include all the Sections indicated below

Part 1 Bidding Procedures

- Section 1 Instructions to Bidders (ITB)
- Section 2 Bid Data Sheet (BDS)
- Section 3 Evaluation and Qualification Criteria
- Section 4 Bidding Forms

Part 2 Sale Requirements

- Section 5 Detailed list of Disposal
 - Part 3 Contract
- Section 6 Contract Forms

- 3.2 The Disposal Documents should be obtained directly from the Disposing Entity or PPDA WEBSITE.
- 3.3 The Bidder is expected to examine all instructions, forms, terms, and specifications in the Disposal Documents. Failure to furnish all information or documentation required by the Disposing Documents may result in the rejection of the bid.

4. Viewing of Assets

4.1 Viewing of assets shall be done by contacting the Disposing Entity staff's address and contact numbers indicated in the BDS.

Preparation of Bids

5. Cost of Bidding

5.1 The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Disposing Entity shall not be responsible or liable for those costs, regardless of the conduct or outcome of the disposal process.

6. Documents Comprising the Bid

- 6.1 The Bid shall comprise the following:
 - (a) Bid Submission Sheet and the applicable Price Schedules
 - (b) Bid Security
 - (c) written confirmation authorising the signatory of the Bid if the bidder is a Company.
 - (d) any other document required in the BDS.

7. Bid Submission Sheet and Price Schedules

- 7.1 The Bidder shall submit the Bid Submission Sheet using the form furnished in Section 4, Bidding Forms. This form must be completed without any alterations to its format, and no substitutes shall be accepted. All blank spaces shall be filled in with the information requested
- 7.2 The Bidder shall submit the Price Schedules using the forms furnished in Section 4, Bidding Forms. The Price Schedule Forms shall indicate, as appropriate:
 - (a) the Lot number:
 - (b) a brief description of the disposed item
 - (c) quantity;
 - (d) total price per Lot;

- (e) Asset reference number
- (f) authorised signature.

8. Bid Security

- 8.1 The Bidder shall furnish as part of its bid, a bid security in original form and in the amount and currency specified in the BDS.
- 8.2 Any bid not accompanied by a substantially responsive bid security shall be rejected by the Disposing Entity as nonresponsive
- 8.3 The bid security shall be returned as promptly as possible once the successful Bidder has signed the Contract as specified in BDS.
- 8.4 The bid security may be forfeited:
 - (a) if a Bidder withdraws its bid before the end of the disposal process, or
 - (b) if the successful Bidder fails to sign the Contract .

9. Format and Signing of Bid

- 9.1 The Bidder shall prepare one original of the documents comprising the bid as described in ITB Clause 7 and clearly mark it "ORIGINAL." In addition, the Bidder shall submit copies of the bid, in the number specified in the BDS and clearly mark them "COPY." In the event of any discrepancy between the original and the copies, the original shall prevail.
- 9.2 The original and all copies of the bid shall be typed or written in indelible ink and shall be signed by a person duly authorised to sign on behalf of the Bidder. This authorisation shall consist of a written confirmation as specified in the BDS and shall be attached to the bid. The name and position held by each person signing the authorisation must be typed or printed below the signature. All pages of the bid shall be signed or initialled by the person signing the bid.

Submission and Opening of Bids

10. Sealing and Marking of Bids

- 10.1 The Bidder shall enclose the original and each copy of the bid in one sealed envelope, d "ORIGINAL" and "COPY."
- 10.2 The envelope shall:
 - (a) be addressed to the Disposing Entity as indicated in BDS
 - (b) bear the subject of the disposal reference number indicated in the BD

11. Deadline for Submission of Bids

11.1 Bids must be received by the Disposing Entity at the address and no later than the date an BDS.

12. Late Bids

12.1 The Disposing Entity shall not consider any bid that arrives after the deadline for submission of bids. Any bid received by the Disposing Entity after the deadline for submission of bids shall be declared late, rejected, and returned unopened to the Bidder.

13. Bid Opening

13.1 The Procuring Entity will prepare a record of the bid opening that shall include, as a minimum: the name of the Bidder and the Bid Price per lot. The Bidders' representatives who are present shall be requested to sign the record. The omission of a Bidder's signature on the record shall not invalidate the contents and effect of the record. A copy of the record may be provided to Bidders upon request.

Evaluation and Comparison of Bids

14. Preliminary Examination of Bids

- 14.1 The Procuring Entity shall confirm that the following documents and information have been provided in the Bid. If any of these documents or information is missing, the bid shall be rejected.
 - (a) Bid Submission Sheet
 - (b) Price Schedules;
 - (c) Written confirmation of authorisation to commit Bidder; and
 - (d) Bid Security

15. Evaluation of Bids

15.1 To evaluate a bid, the Procuring Entity shall only use the criteria defined in Section 3, Evaluation and Qualification Criteria. No other criteria or methodology shall be permitted.

16. Comparison of Bids

16.1 The Procuring Entity shall compare all substantially responsive bids to determine the highest evaluated bid.

Award of Contract

17. Award Criteria

17.1 The Procuring Entity shall award the Contract to the Bidder whose bid has been determined to be the highest evaluated bid and is substantially responsive to the disposal Documents.

18. Notification of Award

18.1 Until a formal contract is prepared and executed, the notification of award shall constitute a binding Contract.

19. Signing of Contract

19.1 Promptly after notification, the Procuring Entity shall send the successful Bidder the contract documents as indicated in BDS.
