### **EXTENSION OF WATER DISTRIBUTION NETWORK AT LUMBADZI HOUSING ESTATE**

1. Lilongwe Water Board has budgeted funds for 2025/2026 Financial Year and intends to apply part of the proceeds for the Procurement of Works for **Extension of Water Distribution Network at Lumbadzi Housing Estate**.
2. The Lilongwe Water Board now invites sealed bids from eligible Bidders, registered with National Construction Industry Council (NCIC) under Civil Class – **MK500 Million Category** or above for the Procurement of Works for **Extension of Water Distribution Network at Lumbadzi Housing Estate** whose main scope shall involve:
  - Reinstatement Works
  - Supply and Installation of pipes & fittings;
  - Construction of manhole chambers
3. The Works shall be completed within 60 days after commencement Date.
4. Bidding will be conducted through National Competitive Bidding (NCB) procedures and in full compliance with the provisions of Malawi's Public Procurement and Disposal of Public Assets Act No. 27 of 2025 and its Subsidiary Legislations. Bidding is open to all bidders as defined in the Bidding Document.
5. Eligible interested bidders may obtain further information and inspect the Bidding Document from the Procurement and Disposal Unit at the address given in 8(a) below from 08:00 to 16:00 hours local time (Monday to Friday) except on national public holidays.
