The Greenbelt Authority (Authority) was established by the Greenbelt Authority Act No 23 of 2017 to champion large-scale commercial irrigation whose main purpose is to accelerate social-economic transformation through increased agricultural productivity, agro-processing and easy access to markets.

The Authority has budgeted public funds for the 2024/25 Fiscal Year and intends to use part of the funds towards for Construction of Greenbelt Nthola Ilora Rice Milling and Processing Factory Support infrastructure in Karonga District and now invites sealed bids from eligible bidders registered with National Construction Industry Council in **Unlimited Building category**.

Bidding will be conducted in accordance with the **open tendering, National Competitive Bidding (NCB) procedures** contained in the **Public Procurement and Disposal of Public Assets Act of 2017** and **Public Procurement Regulations of 2020** of the Government of the Republic of Malawi, and this is open to all eligible bidders.

Bidders must bring an authentic copy of the stamped and signed bank deposit slip when collecting the bids.
6. Interested bidders are requested to attend a **mandatory site visit and pre-bid meeting** at **Nthola Ilora Irrigation Site** in **Karonga District** on **Thursday, 18th April, 2024 at 9am local time**.
7. All bids must be accompanied by a **Bid Securing Declaration Form**.
8. All prospective bidders are further informed that a **Margin of Preference** and application of **Indigenous Black Malawian guidelines** will be used during the process of reviewing the bids.
