- 5. A complete set of bidding documents in English may be purchased by interested bidders at the address below in paragraph 9 (b) and upon payment of a non-refundable fee of MK10,000.00 (Ten Thousand Malawi Kwacha only).
- 6. Bids in sealed envelopes and clearly marked with the tender number must be delivered at the address given below in paragraph 9 (c) on or before Wednesday 09th July, 2025, 10:00 hours (local time). Electronic bidding will not be permitted. Late bids will be rejected and shall be returned to the owners unopened. All bids must be accompanied by a Bid Securing Declaration.
- 7. Bids will be opened in the presence of the bidders' representatives, who choose to attend in person at the address in 9 (d) below on Wednesday 09th July, 2025, 10:00 hours (local time).
