## Date of Issue: Saturday, 26<sup>th</sup> July 2025

- Lilongwe Water Board has budgeted funds for 2025/2026 Financial Year and intends to apply part of the proceeds for the procurement of works for the two separate procurement activities namely: Rehabilitation Works of Treatment Works I & II and Rehabilitation and External Works for Kamuzu Dam II Sailing Club House.
- The Lilongwe Water Board now invites sealed bids from eligible Bidders, registered with National Construction Industry Council (NCIC) under Building Class – MK500 Million Category or above for the following detailed procurement activities:

Bidding will be conducted through National Competitive Bidding (NCB) procedures and in full compliance with the provisions of Malawi's Public Procurement and Disposal of Public Assets Act No. 27 of 2025 and its Subsidiary Legislations. Bidding is open to all bidders as defined in the Bidding Document.
- 4. Eligible interested bidders may obtain further information and inspect the Bidding Document from the Procurement and Disposal Unit at the address given in 8(a) below from 08:00 to 16:00 hours local time (Monday to Friday) except on national public holidays.
- 5. A complete set of Bidding Documents in English language may be purchased by interested bidders at 8(b) upon payment of non-refundable fee of K15,000.00 (Fifteen Thousand Kwacha only) for each document.
- Sealed Bids marked with the procurement reference number should be deposited in the Tender Box on or before Thursday, 14<sup>th</sup> August 2025 at 15:00 hours local time. Electronic bidding will not be permitted.
