5. A complete set of Bidding Documents in English Language may be inspected, purchased by interested bidders from the address shown in 8(b) below and upon payment of a non-refundable fee of **MK10, 000.00**. The method of payment shall be **Cash**.
6. Bids must be registered and delivered to the address shown in 8(b) below on or before Friday, **25th September 2026, 10:00hours local time**. Electronic bidding **will not** be permitted. ***Late bids will be rejected.*** Bids will be opened in the presence of the bidders or bidders' representatives who choose to attend the bid opening meeting at the address below in paragraph 8(c) on **Friday 25 September 2026 at 10:00hours local time**. Bids shall be valid for a period of 120 (One hundred Twenty) days after bid opening.
