1. The Government of Malawi, through the Ministry of Health's Program Implementation Unit (PIU), has been receiving support from The Global Fund since 2003. The Ministry of Health (MOH) is the public sector Principal Recipient (PR) of the Global Fund grant. To effectively administer and manage the grants, the Ministry established a Program Implementation Unit (PIU) to take on some of the functions of the Principal Recipient in implementing the Global Fund grants.
2. The Chairperson of the Internal Procurement and Disposal of Assets Committee of the Ministry of Health now invites sealed technical and financial proposal bids from eligible firms in Malawi to participate in the tender for consultancy services for data and system migration, enhancement and optimization in the Ministry of Health under the project Medical Supply Chain Digitization.
3. Bidding will be conducted in accordance with the **consultancy selection procedures** specified in the Public Procurement and Disposal of Assets (PPDA) Act 2025 and its Public Procurement Regulations 2020 of the Republic of Malawi.
4. A detailed list of bidder qualification requirements and evaluation criteria can be found in the Request for Proposal Document for this tender process.
