In order to effectively administer and manage the grants, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grants.
2. The Chairperson Internal Procurement and Disposal of Assets Committee now invites sealed Technical Proposal and Financial Proposal bids from eligible Architectural and engineering firms in Malawi.
