The Ministry of Health (MOH) is the public sector Principal Recipient (PR) of the Global Fund Grant. To effectively administer and manage the grants, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grants.
- 2. The Chairperson of the Internal Procurement and Disposal of Assets Committee now invites sealed Technical Proposal and Financial Proposal bids from eligible Architectural and engineering firms in Malawi.
- 3. Bidding will be conducted in accordance with the **consultancy selection procedures** specified in the Public Procurement and Disposal of Assets (PPDA) Act 2025 and its Public Procurement Regulations 2020 of the Republic of Malawi.
