- 1. The Government of Malawi through the Ministry of Health has been receiving support from The Global Fund since 2003. The Ministry of Health (MOH) is the public sector Principal Recipient (PR) of the Global Fund Grant. In order to effectively administer and manage the grant, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grant. The PIU would like to use part of the Global Fund COVID 19 grant to undertake Construction of an Infectious Disease Unit and Associated External Works at Kamuzu Central Hospital, Area 33, Lilongwe, Malawi.
- 2. The Chairperson Internal Procurement and Disposal of Assets Committee now invites sealed bids from eligible bidders with current NCIC registration in the 'Unlimited Category or above categories'.
- 3. Bidding will be conducted in accordance with the National Competitive Bidding (NCB) procedures specified in the Public Procurement and Disposal of Assets (PPDA) Act 2017 and its Public Procurement Regulations 2020 of the Republic of Malawi.
- 4. A detailed bidder qualification requirements and evaluation criteria can be found in the bidding Document for this tender process.
- 5. A complete set of the Bidding document in English language may be purchased by interested bidders upon payment of a non-refundable fee of **MK10**, **000.00** (**Ten Thousand Kwacha only**). - 7. Bids must be delivered by depositing the package in the tender box located on the ground floor EPI BUILDING, Global Fund/GAVI PIU, CHSU- Ministry of Health, Off Mtunthama Road, Area 3, P.O. Box
