1. The Government of Malawi through the Ministry of Health has been receiving support from the Global Fund since 2003. The Ministry of Health (MOH) is the public sector Principal Recipient (PR) of the Global Fund Grant. In order to effectively administer and manage the grant, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grant. The PIU would like to use part of the Global Fund - COVID-19 grant to procure various hospital equipment to support health service delivery in Malawi.
2. The Chairperson, Internal Procurement and Disposal of Assets Committee now invites sealed bids from eligible bidders with current PPDA registration in the **‘MK200 Million or above categories**.

4. Bidding will be conducted in accordance with the National Competitive Bidding (NCB) procedures specified in the Public Procurement and Disposal of Assets (PPDA) Act 2025 and its Public Procurement Regulations 2020 of the Republic of Malawi.

Late bids will be rejected.** A public bid opening event will be held soon after the closing period of the receipt of bids. Bidders or their representatives who wish to attend in person are welcome to participate.
