**Design, Supply, Installation and Commissioning of Solar Hybrid System, and Maintenance Of Existing Solar System**

1. The Government of Malawi through the Ministry of Health has been receiving support from The Global Fund since 2003. The Ministry of Health (MOH) is the public sector Principal Recipient (PR) of the Global Fund Grant. In order to effectively administer and manage the grant, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund. The PIU would like to use part of the Global Fund - COVID 19 grant to Design, Supply, Installation and Commissioning of Solar Hybrid System, and Maintenance of existing Solar system for various offices in order to support the administration of health service delivery in Malawi.
2. The Chairperson Internal Procurement and Disposal of Assets Committee (IPDC) now invites sealed bids from eligible bidders with current PPDA registration in the **‘up to MK500 Million and above category’**.
3. Bidding will be conducted in accordance with the National Competitive Bidding (NCB) procedures specified in the Public Procurement and Disposal of Assets (PPDA) Act 2017 and its Public Procurement Regulations 2020 of the Republic of Malawi.
4. A detailed bidder qualification requirements and evaluation criteria can be found in the bidding Document for this tender process.
5. A complete set of the Bidding document in English language may be purchased by interested bidders upon payment of a non-refundable fee of **MK5, 000.00 (Five Thousand Kwacha only)**. 8. Bids must be delivered by depositing the package in the tender box located on the – ground floor EPI BUILDING of the Global Fund – PIU, CHSU- Ministry of Health, Off Mtunthama Road, Area3, P.O. Box 30377, Lilongwe, Malawi, no later than **29th February 2024**, at 14:00 PM local time. Electronic submission will not be accepted. Late bids will be rejected.
