The Chairperson, Internal Procurement and Disposal Committee, Department of Buildings, now invites sealed bids from interested, eligible and qualified **Building Contractors** who are currently registered in the **K5Billion Category** with National Construction Industry Council of Malawi (NCIC) as specified in the bidding documents.
- 3. Bidding will be conducted in accordance with the Open Tendering, National Competitive Bidding (NCB) Procedures, contained in the Public Procurement and Disposal of Asset Act (2017) and Regulations of the Government of the Republic of Malawi and is open to all qualified and eligible bidders
- **4.** A complete set of bidding documents in English may be purchased by interested bidders at the address below upon payment of a non-refundable fee of **MK 30,000.00**, from **Monday 17**<sup>th</sup> **February, 2025.** Payment should be in cash in the Accounts office only.

- 5. Please note that the bidding documents will have to be collected in person and no document will be sent by mail under any circumstances. Limited number of documents is available and the same shall be issued on first come first served basis.

- 7. A mandatory pre-bid meeting shall be held at 10am on Tuesday 25<sup>th</sup> February, 2025 at the Ministry of Transport and Public Works in the Conference room Capital Hill-Lilongwe
- 8. Bids in sealed envelopes and clearly marked with the tender number must be delivered at the address given below on or before Wednesday 12<sup>th</sup> March, 2025, 10:00 hours. Electronic bidding will not be permitted. All bids must be accompanied by a Bid Securing Declaration.

- 9. Late bids will be rejected and returned unopened. Bidders and/or their representatives and members of the general public, may attend the opening of the bids at 10:00 Hrs local time at the address given below on or before Wednesday 12<sup>th</sup> March, 2025 in the Conference Room at Ministry of Transport and Public Works-Capital Hill-Lilongwe.
- 10. It is the responsibility of each Bidder to ensure that bids are submitted in accordance with "Instructions to Bidders" in the bidding documents, as non-compliance to the instructions will lead to disqualification and rejection of the bid.
- 11. Bids shall be valid for a period of **120 days** after bid opening.
- 12. The Malawi Government does not bind itself to accept the lowest priced or any bid, but reserves the right to exercise choice of the lowest evaluated substantially responsive bid in accordance with what it considers to be in its best interest.
