- 1. The Government of Malawi through the Ministry of Health Program Implementation Unit (PIU), has been receiving support from The Global Fund since 2003. The Ministry of Health (MOH) is the public sector Principal Recipient (PR) of the Global Fund Grant. To effectively administer and manage the grants, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grants. The PIU is inviting bidders to participate in the Tender for Construction and Completion of Health Posts in Ntchisi District.
- 2. The Chairperson Internal Procurement and Disposal of Assets Committee now invites sealed Technical Proposal and Financial Proposal bids from eligible Contractors in the **Five** (5) Billion Kwacha NCIC Category in Malawi.
- 3. Bidding will be conducted in accordance with the **National Competitive Bidding (NCB) procedures** specified in the Public Procurement and Disposal of Assets (PPDA) Act 2025 and its Public Procurement Regulations 2020 of the Republic of Malawi.
- 4. A detailed bidder qualification requirement and evaluation criteria can be found in the Bid Document for this tender process.
