1. The Government of Malawi, through the Ministry of Health – Program Implementation Unit (PIU), has been receiving support from The Global Fund since 2003. The Ministry of Health (MOH) is the principal recipient (PR) of the Global Fund Grant in the public sector. To effectively administer and manage the grants, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grants. The PIU is inviting bidders to participate in the tender for the Rehabilitation and Completion of the Isolation and Infectious Ward at Chikwawa District Hospital.
2. The Chairperson Internal Procurement and Disposal of Assets Committee now invites sealed bids from eligible contractors in the **Five (5) Billion Kwacha NCIC Category** in Malawi.
3. Bidding will be conducted in accordance with the **National Competitive Bidding procedures** specified in the Public Procurement and Disposal of Assets (PPDA) Act 2025 and its Public Procurement Regulations 2020 of the Republic of Malawi.
