Bidding will be conducted through open tendering procedures under Request for Quotation (RFQ) procedures as specified in the Malawi Public Procurement and Disposal of Assets Act 2024 and Regulations of the Government of the Republic of Malawi, and are open to all Contractors /bidders from Eligible Source. The successful bidder shall however be required to produce a valid registration certificate with National Construction Industry Council as a condition for award of contract
- 4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below from 08:00 to 12:00; 13:00 to 16:00 hour's local time (Monday to Friday except national public holidays)
- 5. The bidding document is not for sale therefore bidders must request a soft copy from the procurement Department by sending an email to 8.

Bids must be valid for Ninety (90) days after bid opening and must be delivered to the address in 8(a) and deposited in the box marked "IPDC Tender Box" that will be placed at the entrance of Mangochi Mangochi District Commissioners Offices at or before 10:00hrs Local Time on All bids must be delivered to the address in 9(c) and submitted at the procurement Office, marked "IPDC Tender Box" at or before 14.00 Hours Local Time on Friday 23<sup>rd</sup> May 2025
