1. Introduction

The Electricity Generation Company (Malawi) Limited (EGENCO) has identified potential energy projects for development as Carbon Credit initiatives under Article 6 of the Paris Agreement. These climate mitigation projects also aim to support Malawi's Nationally Determined Contributions (NDCs) to meet its commitment of contributing to reduction of Greenhouse Gas (GHG) emissions while promoting increased access to clean and affordable electricity.

In view of the above, EGENCO seeks the services of experienced and qualified carbon experts to support the development of Project Design Documentation, submissions to relevant authorities and obtaining necessary approvals for advancement of the projects. The ideal candidate will ensure that all documentation meets Article 6 requirements, relevant international standards, and carbon financing protocols, ensuring technical accuracy and methodological compliance.

The successful individual consultant will undertake a comprehensive review and enhancement of existing project documents prepared by the Carbon Market Task team to align with the requirements of EGENCO's prospective

development partner, facilitate project registration with relevant registries and authorities, and develop detailed Terms of Reference (ToRs) for the Validation and Verification Body (VVB) Consultant.

2. Objectives of the assignment

2.1. Main Objective

The primary objective of this assignment is to design, develop, and register carbon project documentation for two selected renewable energy projects, ensuring compliance with Article 6 of the Paris Agreement, development partner requirements, and carbon financing requirements.

2.2. Specific Objectives

- i. To review, align and enhance existing Main Activity Idea Note (MAIN) documents
- ii. To develop detailed Project Design Documents (PDD/MADD) to meet Article 6 of Paris Agreement requirements, development partner requirements and Carbon financing requirements.
- iii. To develop Terms of Reference for the recruitment of the Validation and Verification Body (VVB) Consultant.

3. Consultant Qualifications and Requirements

The Consultant shall meet the following qualifications and requirements:

- i. Master's degree in economics, Finance, Business Administration, Engineering, Law, Environmental Science, Climate Change, Energy or related fields.

- ii. At least 5 years of relevant professional experience in carbon markets with specific knowledge in carbon finance, Nationally Determined Contributions and the Paris Agreement.
- iii. Proven experience in preparing Energy carbon Projects documentation (e.g., PDD, MAIN, SD tools).
- iv. Demonstration of strong understanding of environmental and social safeguards.
- v. Proven knowledge of climate change mitigation measures in developing countries.
- vi. Demonstrated experience with the development of carbon finance projects in developing countries.
- vii. Demonstrate knowledge with Malawi Climate change policies including Carbon Market Framework.
- viii. Knowledge of recognized carbon certification standards, operational procedures and requirements, UNFCCC mechanisms, Verra, Gold Standard and other compliance market standards.
- ix. Knowledge of Malawi's carbon credits and regulatory frameworks which should be substantiated by documentary evidence.

4. Proposal Preparation

Interested consultants should submit:

- i. A technical proposal briefly detailing understanding of the assignment and approach (Not more than a Page).
- ii. Curriculum Vitae highlighting relevant experience.
- iii. Relevant academic qualifications.
- iv. Record of similar works with traceable referees.
- v. Tax registration and complaint certificates.
