## INVITATION OF EXPRESSION OF INTEREST FOR CONSULTANCY SERVICES FOR DESIGN, DESIGN REVIEW AND CONSTRUCTION SUPERVISION OF SOME ACCESS ROADS IN THE CITIES OF LILONGWE AND BLANTYRE: PROCUREMENT REFERENCE NO. 130/IPDC/NCB/AR/25-01 DATE OF ISSUE: 10<sup>th</sup> JULY,2025.

- **1.0** The Government of the Republic of Malawi, through the Ministry of Lands, has budgeted funds and intends to apply part of the proceeds of these funds towards the cost of Design, Design Review, and Construction Supervision of Some Access roads in the Cities of Lilongwe and Blantyre.
- 2.0 The Chairperson, Internal Procurement and Disposal Committee, Ministry of Lands, now invites suitably qualified consulting firms ("Consultants") to submit sealed Expressions of Interest (EOI) for Consulting Services for Design, Design Review, and Construction Supervision of Some Access Roads in the Cities of Lilongwe and Blantyre.
- **3.0** The contracts are for the provision of Consultancy Services for Design, Design Review, and Construction Supervision of Some Access Roads in lots 1,2 and 3 as shown in the table below:

- 5.0 Expressions of interest will be evaluated in accordance to the Public Procurement and Disposal of Assets Act 2025. Participation is open to all eligible bidders. Only Shortlisted firms SHALL be invited to submit proposals.
- 6.0 Interested eligible bidders may submit their Expression of Interest at the address at 8 below at or before 2:00PM on 29<sup>th</sup> July, 2025. Late EOIs will be rejected.
- 7.0 Consulting firms should be eligible by showing their legal status in accordance with the laws of the Republic of Malawi by having the following valid certificates:
  - a) Certificate of registration with registrar of business names,
  - b) National Construction Industry Council (NCIC),
  - c) Tax Clearance Certificate from Malawi Revenue Authority,
  - d) VAT Registration certificate,
  - e) PPDA Certificate,
