#### a) Team Leader / Senior Architect

Master's Degree in Architecture with at least 10 years experience including the designing of education facilities and must be registered with the relevant professional bodies;

#### b) Architect (2 No.)

Bachelor of Science in Architecture with at least 7 years practical experience and must be registered with the relevant professional body;

#### c) Quantity Surveyor (2 No.)

Bachelor of Science in Quantity Surveying with at least 7 years practical experience and must be registered with the relevant professional body;

## d) Structural Engineer (2 No.)

Bachelor of Science in Civil/Structural Engineering with at least 7 years practical experience and must be registered with the relevant professional body;

#### e) Electrical/Mechanical Engineer (2 No.)

Bachelor of Science in Electrical/Mechanical Engineering with at least 7 years practical experience and must be registered with the relevant professional body;

## f) Environmental and Safeguards Specialist (2 No.)

Bachelor of Science in Environmental Sciences with at least 7 years practical experience and must be registered with the relevant professional body;
