- Bidding will be conducted in accordance with the disposal of public assets through open tendering with sealed bids and in full compliance with the provision of Malawi Public Procurement and Disposal of Public Assets Act No. 7 of 2025 and its Subsidiary Legislations. All bids must be accompanied with a valid National Identity in full colour.
- Interested eligible bidders may obtain further information **from Ministry of Industrialisation, Business, Trade and Tourism** and inspect the public assets to be disposed off at the address given below at 11 (a) from **9:00 am to 12:00 noon and from 1:00 pm to 4:00 pm local time (Monday to Friday, except on Public Holidays)** or through email from chipaojacque@gmail.com, sphiwemauwa@gmail.com.
- Bidders will be allowed to bid for one or multiple items and evaluation of bids will be done on item basis. However, successful bidders will only be allowed to purchase one motor vehicle unless there is no other bidder.
- In line with the Public Procurement and Disposal of Assets Act, 2025, Ministry of Industrialisation, Business, Trade and Tourism Officials or their relatives (children, spouses, siblings, parents or guardians) will not be allowed to participate in the bidding process.

8. **DEPOSIT**

All bidders shall be required to pay a refundable deposit of **MK 200,000.00/ item** when submitting their bids. The deposit is **REFUNDABLE** only when a bidder is not successful and **FORFEITED** when a successful bidder declines to take up one's bid for whatever reasons. Refunds shall be done **ONLY** upon concluding the contract with the winning bidder.

9. Successful bidders shall be required to pay **100%** of the contract price before collection of the assets within **30days** from date of award of contract. Allowable Modes of Payment are **STRICTLY CASH**.

10. Sealed bids marked with disposal reference number should be delivered to the address at 11(b) below and deposited in the Tender Box on or before **Tuesday, 3rd February, 2026 at 10:00 am local time**. Electronic bidding will not be permitted and late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address given at 11(c) below at **10:00 am local time** Tuesday, **3rd February, 2026**.
