6. Requests for clarifications from Bidders to CRWB shall be made no later than **Seven days** prior to bid submission as indicated above
7. Bids should be clearly marked **according to choices by Bidders from the above list** and must be delivered to the address shown at "11(b)" below on or before **Closing dates at indicated times on the above table**. All Bids must be accompanied by a duly completed bid securing declaration form.
8. Late Bids shall be rejected
9. Bids will be opened at **Central Region Water Board Conference Room** in the presence of bidders 'representative who choose to attend on dates and times indicated above
