The Government of Malawi through the Ministry of Health has been receiving support from The Global Fund since 2003. The Ministry of Health (MOH) is the public sector Principal Recipient (PR) of the Global Fund Grant. In order to effectively administer and manage the grant, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grant. In Line with the MOH **HIS** Policy the central monitoring and evaluation division (CMED) in the department of Planning and policy Development coordinates implementation of HMIS activities at all Levels of the sector in the country .CMED is facilitating procurement of key HMIS registers required by the Programs to avert stock outs and prevents data loss . Ministry of Health -PIU now invites eligible bidders to participate in the tender for supply of HMIS registers

The bidding process consist of Three **(3)** lots, Bidders are invited to bid for all items in each lot **(Details are in the Bidding Document) but no any bidder will be awarded more than one LOT .**

1. Bidding will be conducted in accordance with the National Competitive Bidding (NCB) procedures specified in the Public Procurement and Disposal of Assets (PPDA) Act 2025 and its Public Procurement Regulations 2020 of the Republic of Malawi.
2. A detailed bidder qualification requirements and evaluation criteria can be found in the bidding Document for this tender process.
3. A complete set of the Bidding document in English language may be purchased by interested bidders upon payment of a non-refundable fee of **MK10, 000.00 (Ten Thousand Kwacha only)**.
