Sealed bids, clearly marked on the outer envelope with "Tender Description and Reference Number" must be deposited in the Tender Box at address at 6(c) below at or before 10.00 a.m.(local time) on Friday 20th September, 2024. All bids must be accompanied by a duly signed Bid Securing Declaration Form or Bid Security. Late Bids will be rejected and returned to the bidder unopened.
