



REQUEST FOR PROPOSALS (RFP) FOR THE ANNUAL AUDITS OF THE FINANCIAL STATEMENTS OF THE NATIONAL AUDIT OFFICE.

1.0. INTRODUCTION

The Parliamentary Committee on Public Accounts is a committee that is established under Part IV of the Public Audit Act and under Standing Order 161. The Committee is established to give effect to the principle of the accountability of Government to the public by holding accountable Ministries, Agencies and other entities controlled by Government for the lawfulness, economy, efficiency and effectiveness with which they use public money and public resources.

Under Section 28 (1) of the Public Audit Act, it is required that the Public Accounts Committee of Parliament shall appoint Competent Public Auditors to conduct annual audits of the financial statements of the National Audit Office. Pursuant to the provisions of Section 28 (2) of the same Act, the National Audit Office has its financial statements for the years ended 31st March, 2022, 2023, 2024 and 2025 ready for audit.

The Public Accounts Committee, therefore, calls for expression of interest from competent public auditors to conduct the audit exercise as explained above.

2.0. REQUEST FOR PROPOSALS

The Public Accounts Committee would like to seek the services of an Audit Firm to assist in auditing the National Audit Office. In this regard, the Committee seeks Technical and Financial Proposals from reputable Audit firms for this appointment. Interested firms must provide information indicating that they are qualified to perform the required services. The information must contain the firm's profile including qualifications, experience of partners, at least three

references from other corporate clients, descriptions of similar assignments undertaken, experience in similar conditions as a firm, availability of relevant and appropriate skills and expected Fees. Requirements should include but not limited to the following:

3. GENERAL REQUIREMENTS

The Audit firm is expected to be fully self-sufficient in terms of office space, supplies, communications, and transport during the assignment and to discharge its responsibilities to the expected professional standards and integrity.
