#### A) INTRODUCTION

The Ministry of Transport and Public Works has established the Malawi Cargo Logistics Limited. The new company will focus on the following:

- 1. Develop, maintain and manage the Malawi Cargo Centre's facilities in Dar es Salaam and Mbeya in Tanzania and any other place in that country, Malawi, or any other country where such or similar facilities may be located.
- 2. Establish and carry on any business, trade or undertaking and be involved in any transaction for the management, movement, storage, transportation or other dealing with cargo of whatsoever nature for import or export to and from Malawi and other countries through the Malawi Cargo Centre's facilities or such similar facilities in Malawi or elsewhere
- 3. Mobilize such resources, financial, human, technical or any other kind as may be required to make the Malawi Cargo Centre viable for transportation and infrastructure for the transportation of imports and exports for Malawi and any other country.

- 1. Be easily recognizable as a face and identity of the company

- 4. Be eye-catching, versatile, relevant and timeless
- 5. Have symbols that reflect the objectives of the company
- 6. Be original

The Ministry will constitute a selection panel that shall review all submissions based on originality and the requirements of the logo.
