- 1. **Blantyre City Council (BCC)** is mandated provide environmentally friendly, high quality, efficient, and effective demand-driven municipal services in partnership with individual and corporate residents to improve the quality of life for all residents in the City. With funding from the Roads Fund Administration and The Central Government, the Council is inviting sealed bids from eligible bidders for Reshaping and Associated Routine Maintenance Works of Somanje via Roman Catholic to Chilobwe in Green Corner Ward (2km) and Zingwangwa Chipatala and Malingamoyo Ring Road in Soche West Ward (2km).
- 2. In accordance with Section 36 of the Public Procurement and Disposal of Assets Act 2017 and Para.14 of the Public Procurement and Disposal of Assets (Participation by Micro, Small and Medium Enterprises) MSME Order 2020, the Council is now soliciting sealed bids from eligible Medium Enterprises for Reshaping and Associated Routine Maintenance Works of Somanje via Roman Catholic to Chilobwe in Green Corner Ward (2km) and Zingwangwa Chipatala and Malingamoyo Ring Road in Soche West Ward (2km).
- 3. This procurement is exclusively for Medium Enterprises. Eligible bidders must obtain a valid registration certificate from the National Construction Industry Council (NCIC) in the MK100 million to MK200 million Civil Engineering Category.
- 4. Bidding will be conducted in accordance with the National Competitive Bidding procedures contained in the Public Procurement and Disposal of Assets Act, 2017 and Public Procurement Regulations, 2020, and MSME Order 2020.

- 5. Blantyre City Council shall further prioritize the submitted bids in line with Section 44 (10) of the Public Procurement and Disposal of Public Assets Act 2017 and the circular issued by the Public Procurement and Disposal of Assets Authority (PPDA) on 1st July, 2019. Please take note that all indigenous Malawians shall enjoy 20% margin of preference.
- 6. Bids clearly marked; "Tender for Reshaping and Associated Routine Maintenance Works of Somanje via Roman Catholic to Chilobwe in Green Corner Ward (2km) and Zingwangwa Chipatala and Malingamoyo Ring Road in Soche West Ward (2km) must be delivered to the address shown at 7 (a) below on or before 3rd September, 2024 at 16:00 Hours. Late bids shall be rejected.
