- 1) Bidding will be conducted in accordance with the National competitive bidding (NCB) procedures contained in the Public Procurement Law and Regulations of the Government of Malawi and is open to all bidders from eligible source countries. A bidder shall be required to obtain a certificate of registration from the Construction Industry Regulatory Authority (CIRA) in a relevant category specified in the document demonstrating registered Contractor status for the works, as a condition of contract award.

- 4) The complete bidding documents must be delivered to The Chairperson, IPDC M'mbelwa District Council, P.O Box 132, Mzimba no later than 3rd July, 2026 at 10.00hrs local time. Late bids shall be rejected. Bids will be opened in the presence of bidders' representatives who choose to attend at M'mbelwa District Council, Sandton Conference Hall next to Mzimba National Bank on 3rd July, 2026 at 10.00hrs. M'mbelwa District Council is not bound to accept the lowest or any other bid and may reject any or all of the bids
