Technical specifications of the tree seedlings.

To ensure higher survival of the planted tree seedlings, the trees must meet the following technical specifications:

1. The tree seedlings should be of high quality, green and at least 45 cm long
2. The tree seedlings' diameter should be at least pencil-size
3. The seedlings should come within the same silvicultural zones (areas with the same climatic and edaphic factors within Mangochi).
4. The tree seedlings should have been raised at the nursery for at least 3 months for fast-growing species and 6 months for slow-growing species.
5. The tree seedlings should undergo a hardening-off process
6. The tree seedlings should be pests and disease free after inspection
7. The tree seedlings should be raised in pots and subjected to root pruning

8. Tree nurseries will be inspected to ensure full compliance of the above technical requirements before the award of the contract
