- 1. The Greenbelt Authority (Authority) was established by the Greenbelt Authority Act No 23 of 2017 to champion large-scale commercial irrigation whose main purpose is to accelerate social-economic transformation through increased agricultural productivity, agro-processing and easy access to markets.
- 2. The Authority has budgeted public funds for the 2025/26 Fiscal Year and intends to use part of the funds towards for rehabilitation of Lweya Megafarm in Nkhatabay District and now invites sealed bids from eligible bidders registered with National Construction Industry Council in five(5) billion Civil Engineering category as follows:

 Bidding will be conducted in accordance with the open tendering, National Competitive Bidding (NCB) procedures contained in the Public Procurement and Disposal of Public Assets Act of 2017 and Public Procurement Regulations of 2020 of the Government of the Republic of Malawi, and this is open to all eligible bidders.

- 4. **Pre-bid Meeting**: The Greenbelt Authority shall arrange a mandatory prebid meeting and site Visit. The pre-Bid meeting and site visit shall take place on 6th March 2025 at Lweya Mega Farm Warehouse in Nkhatabay District from 1:30 hours local time.
