CONSTRUCTION SUPERVISION OF ROAD AND BRIDGE MAINTENANCE WORKS 2025-2026 FINANCIAL YEAR

1. Introduction

The Roads Authority has allocated funds from the Roads Fund Administration and intends to apply part of the proceeds of these funds towards the cost of Construction Supervision Of Road And Bridge Maintenance Works for 2024-2025 Financial Year.

2. Scope of the services

- 2.1. The Services are for the provision of engineering services for the supervision of Routine and Periodic Road maintenance works on assigned portions of the road network under 2025-2026 programme. This is to ensure that the road maintenance works will be carried out in accordance with conditions of contract and specifications.
- 2.2. The scope of the Construction and Maintenance Supervision shall be undertaken in the five operations zones of the RA which are detailed hereunder.

- 2.3. The selected consultants will be required to provide one supervision team on each of the five RA operating Zone of the works.
- 2.4. The duration of the assignment is 12Months from the time of award of the services.

- 2.5. The Roads Authority now invites suitably qualified bidders to submit sealed Request for Proposal for the Construction Supervision of Road and Bridge Maintenance Works.

3. Bidding procedures

- 3.1. Bidding will be conducted in accordance with the open national tendering procedures contained in the Public Procurement and Disposal of Public Assets (PPDA) Act (2017) and the Public Procurement Regulations of 2020 of the Government of the Republic of Malawi and is open to all eligible bidders.
- 3.2. All eligible bidders are required to show evidence of registration with the National Construction Industry Council of Malawi (NCIC) and will have renewed their membership for the current financial year.
