The Government of Malawi through the Ministry of Health has been receiving support from The Global Fund since 2003. The Ministry of Health (MOH) is the public sector Principal Recipient (PR) of the Global Fund Grant. In order to effectively administer and manage the grant, the Ministry established a Program Implementation Unit (PIU) to undertake some of the functions of the Principal Recipient in the implementation of the Global Fund Grant. The Ministry would like to use some of the funds under this grant to procure Servers for supply chain digitalization. Ministry of Health -PIU now invites eligible bidders to participate in the tender for supply & delivery of Servers.

The bidding process consist of One (1) lot. Bidders are invited to bid for all items in the lot (Details are in the Bidding Document).

- 1. Bidding will be conducted in accordance with the National Competitive Bidding (NCB) procedures specified in the Public Procurement and Disposal of Assets (PPDA) Act 2025 and its Public Procurement Regulations 2020 of the Republic of Malawi.
