7. Closing date for Bid Submission is **Monday, 2nd March 2026 at 14:00 Hours**. Bids **will be immediately opened on 2nd March 2026 from 14:00 Hours**, in the Malawi Housing Corporation Head Office Board Room in Blantyre, in the presence of the Bidders or their Representatives who choose to attend.
