The method of payment will be **Cash** or **Bank Certified cheque.**

Bids, clearly marked on the outer envelope with tender name and reference number must be delivered to the address at 7(b) below and deposited in the tender box located on the Second Floor, Ministry of Health Headquarters, Capital Hill, Lilongwe at or before 14:00 hours local time on 11th December, 2023. All bids must be accompanied by a Duly Signed and Stamped Bid Securing Declaration Form. Electronic bidding will Not be permitted and Late bids shall be rejected.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address shown at **7(c)** below at **14:00 hours local time** on **11th December**, **2023**.
