A bidder shall be required to obtain a certificate of registration from the Construction Industry Regulatory Authority (CIRA) demonstrating registered contractor status, as a condition of contract award.

Interested eligible bidders may obtain further information from Zomba District Council and inspect the bidding documents at the address given below at 6(a) from 8:00am to 16:30pm working days only. Interested bidders are requested to attend **a mandatory site visit and pre-bid meeting at Zomba District Council Chamber on Wednesday, 22th July 2026 at 8.00 am** local time.
4. A complete set of Bidding Documents in English may be purchased by interested bidders' application to the address below at 6(b) and upon payment of a non-refundable fee **Mk 35,000.00**. The method of payment will be **cash, and ensure you register your company in the bid purchase register at procurement office upon issuance of General Receipt from Accounts**.
5. Bids must be delivered to the address below at 6(c) at or before **10:00Am on Friday 31 July 2026**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 6(d) at **10:00 am on Friday 31 July 2026**.
